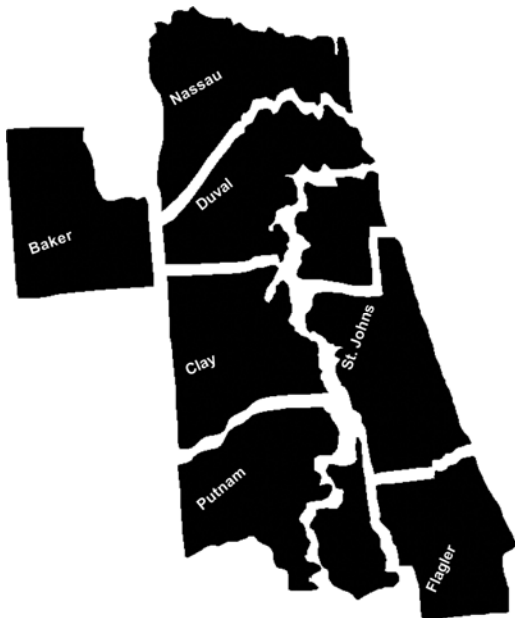
## Foreword
