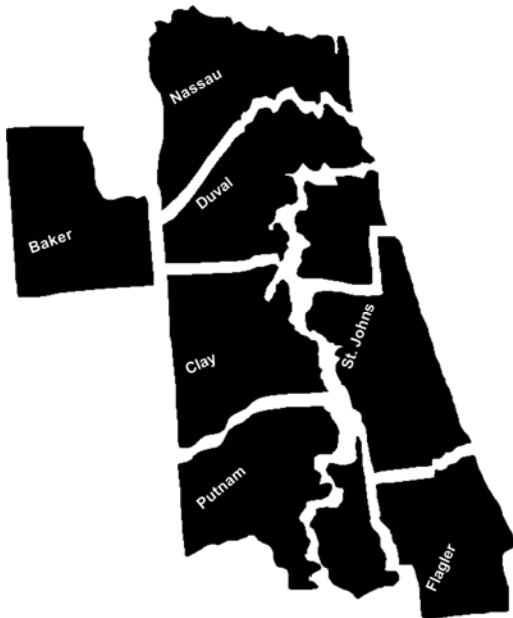
Foreword
